Grandchildren must be accompanied by a financial member when visiting Boathaven. . An optional fee of \$60.00 per year maybe paid for a storage locker (if available). Dinghy racks may also be available at \$40.00 per year.

**Day Visitors:** Members are permitted to invite day visitors to enjoy the benefits of Boathaven on a limited basis. A voluntary donation to use the facilities would be appreciated. Members are permitted to invite overnight visitors to Boathaven, also on a limited basis. All visitors must be accompanied by a financial member.
